# Announcement of Decisions Regarding the Acquisition of Treasury Shares

Yamaha Corporation (hereinafter, the Company) hereby announces that, at the meeting of the Board of Directors held on February 5, 2019, the following items related to the acquisition of treasury shares based on the application of the provisions of Article 156 of Japan's Companies Act pursuant to the rewording of Article 165-3 were resolved.
